Bond County Sheriff's Department and Greenville Police Department Make Arrests in Joint Narcotics Enforcement Operation

On 10/16/2019, The Bond County Sheriff's Department, Greenville Police Department with the assistance of the Bond County States Attorney's Office and Bond County Probation Department conducted a joint Narcotics Enforcement Operation in Greenville and Bond County. During the Wednesday night operation, a total of 11 individuals were taken into custody for narcotics, firearms and outstanding warrants. The following individuals were arrested during the operation and charged through the Bond County States Attorney's Office. All individuals are presumed innocent, until proven guilty.
